INSTRUCTIONS

1. No application shall be entertained unless it is properly filled in and submitted along with necessary documents in conformity with the regulations and instructions of the University.
2. No candidate shall be allowed to alter any subject other than those mentioned in this application provided the candidate is eligible under the regulation to alter such subjects.
3. No application for admission to the Examination shall be entertained after the due date notified by the University. In exceptional cases permission may be granted provided the reasons for the delay were considered to be sufficient and the application along with the requisite fees reached the Controller of Examination within seven days/Fifteen days after the due date with late fee of Rs.20/- and Rs.50/- respectively.
4. The Heads of the Institutions shall forward fees in one or two bank draft(s) made payable to the Comptroller of Finance, Utkal University payable at S.B.I. Utkal University Campus Branch or credit the same in the State Bank of India to the Utkal University Campus Branch in General Fund Account No.-IV.
