EXEMPTIONS: (Only after verification of original document supporting claim for exemption)

- All Girl students who happen to be the only Girl Child(SINGLE GIRL CHILD) are **exempted from paying work experience/computer fee.**
- Children of parents who are living Below Poverty Line and having **BPL Card (upto two children)**, all **PH students, all single girl child students are exempted from paying Pupil's Fund.**
- Children of Armed forces and Para Military Forces Personnel whose parents were killed/declared missing or permanently disabled during any counter insurgency operation in India or abroad, provided the children produce the certificate granted by the concerned Ministry, are exempted from paying Tuition Fee, Work Experience Fee and Pupil's Fund charges.
- Children of officers and men of armed forces and para military personnel killed or disabled during the hostilities 1962,1965,1971 & 1999 and as well as the children of Defence Personnel of Indian Peace Keeping Force [IPKF] in SriLanka and personnel of armed forces killed or disabled in 'Operation Meghdoot' in Saichen area and 'Operation Vijay' in Kargil, are exempted from paying Tuition Fee and Pupils Fund.


- **The admission of the candidate is purely provisional.**
- **Candidate has to produce his/her original documents (correct in all respect) for verification in the school office on the date given below, failing which her/his admission will be cancelled without any further notice.**
- **There should not be any spelling mismatch in all the documents in respect of the candidate and his/her guardian.**
- **There must not be any overwriting or correction in the Original Documents of the candidate. If any, then it must be signed by the competent authority.**

- 7) Aadhar Card & Blood Group Certificate
